# BlackBerry Workspaces for Windows auto-update mechanism

This guide provides an overview for BlackBerry Workspaces system administrators about how to configure the automatic update mechanism capability of the BlackBerry Workspaces for Windows application to your users. Utlizing this feature is reccomended when planning syncronized updates to a large number of users.

By default, all new application versions are included in standard upgrade packages, but are not automatically pushed after upgrades are completed.

### Push auto-update mechanism configuration

To enable the push auto-update mechanism, use the following configuration procedure.

- 1. Two files, both located on the "Main" server, control the push mechanism from an on-premise BlackBerry Workspaces server:
  - /var/www/html/download/VersionManifest.xml
  - /var/www/html/download/VersionManifestSync.xml
- 2. Edit the following parameters in both files.

Once the parameter edits are saved, the new application upgrade will start rolling out to end users.

| LatestVersion           | versionNumber.revisionNumber<br>(e.g.5.5.0.) | Application version that will be<br>pushed to users. Should be the<br>most recent version deployed on<br>the specific server.  |
| PublishedDate           | dd/mm/yyyy                                   | Date in which auto-upgrades<br>will begin. Usually this would be<br>today's date.  |
| MaximumVersionToUpgrade | versionNumber.revisionNumber<br>(e.g.5.5.0.) | This field enables pushing<br>upgrades only to users with older<br>versions of the application. For<br>example, if you wish to push 5.5.0<br>only to users that have versions<br>older than 4.5.0, the value of the<br>field will be 4.5.0.xxxxx. Normally,<br>the value would be identical to<br>"LatestVersion", ensuring that ALL<br>users will be upgraded.  |
| FullUIUpgradeStartDate  | dd/mm/yy                                     | By default, the "push" is silent and<br>no notifcation is shown on the<br>user's screen. Silent notifcations<br>can only execute while 3rd party<br>software is closed on the user's<br>computer. To accellerate the<br>upgrade process, there is an<br>option to push the application<br>with a visable notification for end-<br>users. This field will determine<br>the date when a UI upgrade, with<br>a balloon notification begins. |
