What's new in BlackBerry Share for iOS 3.2.7.103

This release of BlackBerry Share for iOS features an updated BlackBerry Dynamics SDK to address a key iPhone 8 issue.

BlackBerry Dynamics SDK versions

- BlackBerry Dynamics SDK: 3.4.1.82

Fixed issues

- After upgrading, iPhone 8 users experienced the following issues:
 - Received a **Failed to Connect Push Channel** error message when they first started BlackBerry Share.
 - When BlackBerry Share was activated, the app stopped responding when the email address and activation key were entered.
- A retry button was added that allows users to retry authentication delegation if the authentication delegation app is unavailable at the time it was requested.(GD-23853)
